NOTICE TO EXHIBITORS

DOGS MAY ARRIVE any time prior to their scheduled time for judging. After being judged, dogs not required for further judging may be excused. Neither the Club nor Show Secretary will be responsible or obligated to furnish any service for notifying the exhibitors or their class being judged. All dogs present must be held on leash or confined to their crates.

ENTRY FEE shall not be refunded in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from the competition by the Show Committee. The club accepts no responsibility for duplicate, wrong, or incomplete entries. No refund of entry fee will be made if, because of riots, civil disturbances, extreme weather conditions, or other acts beyond the control of the

Show Committee, it is impossible to open or to complete the show.

JUDGES need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

Attention Exhibitors!

OXYGEN MAY BE IN USE. Please refrain from smoking in close proximity to the ring.

There is ample room for private exercise pens alongside the parking lot. Please be considerate and police your own areas.

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Routes to the Show Site:

Going south on I-75:

In Knoxville, continue on I-275 South to I-40 West. Take exit #386B (Rt. 129 Alcoa, Airport, Smoky Mountains). NOTE: the exit is less than one mile from the on ramp, so *watch closely*. Follow Rt 129 towards Alcoa and the airport. Take Hunt Road exit (~0.5 miles past airport), and turn right, over the overpass. Drive approximately 0.4 miles to Springbrook Road, and turn right. Turn left onto Alcoa Road, and then right onto Dalton Street. Show site is on the right.

Going west on I-40:

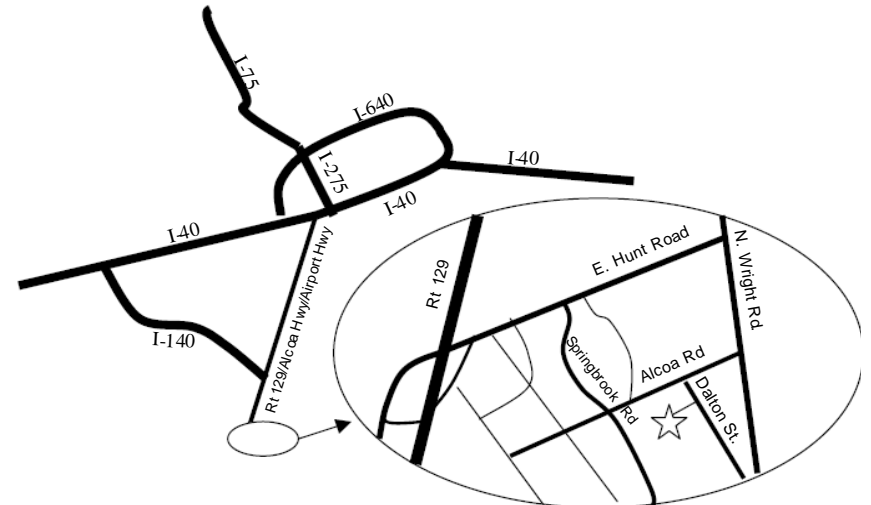
Take Exit #386B (exit sign reads Route 129 Alcoa, Airport, Smoky Mountains). Follow Rt. 129 towards Alcoa and the airport. Same as above directions.

Going east on I-40/North on I-75:

Take Exit #376 in Knoxville, and go towards Maryville/Alcoa on I-140. Exit I-140 at the Alcoa/Route 129 exit, and drive south on Rt 129. Take Hunt Road exit (~0.5 miles past airport), and turn right, over the overpass. Drive approximately 0.4 miles to Springbrook Road, and turn right. Turn left onto Alcoa Road, and then right onto Dalton Street. Show site is on the right.

From host hotel:

Head north on Hall Road, and travel approximately 1 mile towards the airport. Take the Hunt Road exit, and continue to the right on Hunt Road. Drive approximately 0.4 miles to Springbrook Road, and turn right. Turn left onto Alcoa Road, and then right onto Dalton Street. Show site is on the right.

Driving directions: Follow same directions as for show site, except do not exit onto Hunt Road. At fork, stay to the left on Hall Rd/TN-35 and travel about 0.6 mile. Turn right at Associates Blvd and right on Fountain View Circle. Hotel will be on the left.
